



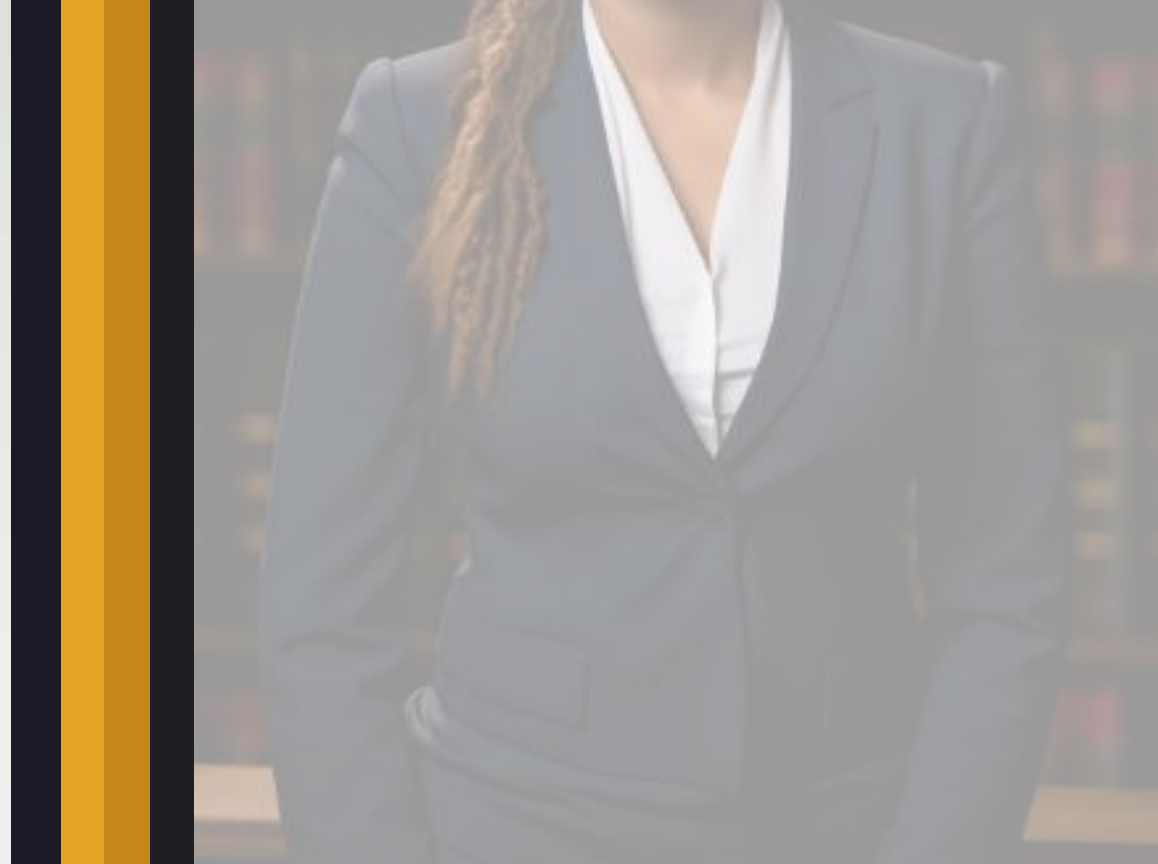

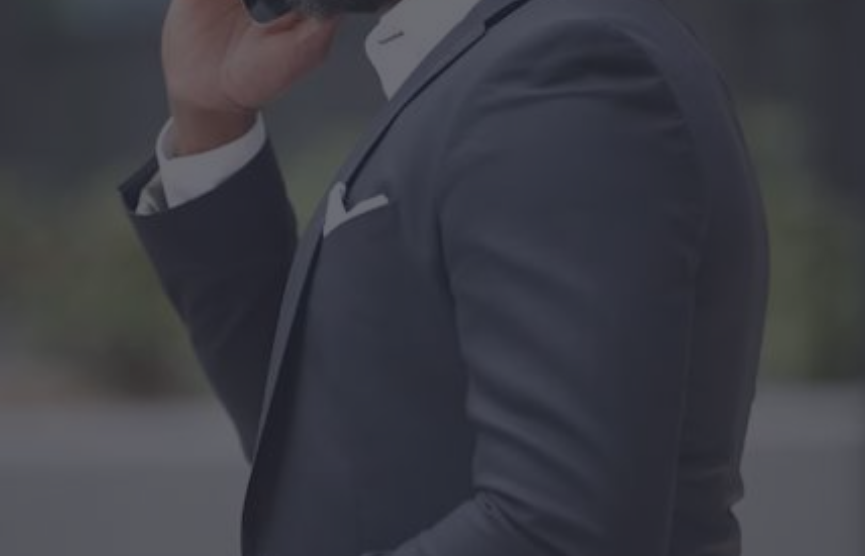

- Consistency and accountability in service delivery



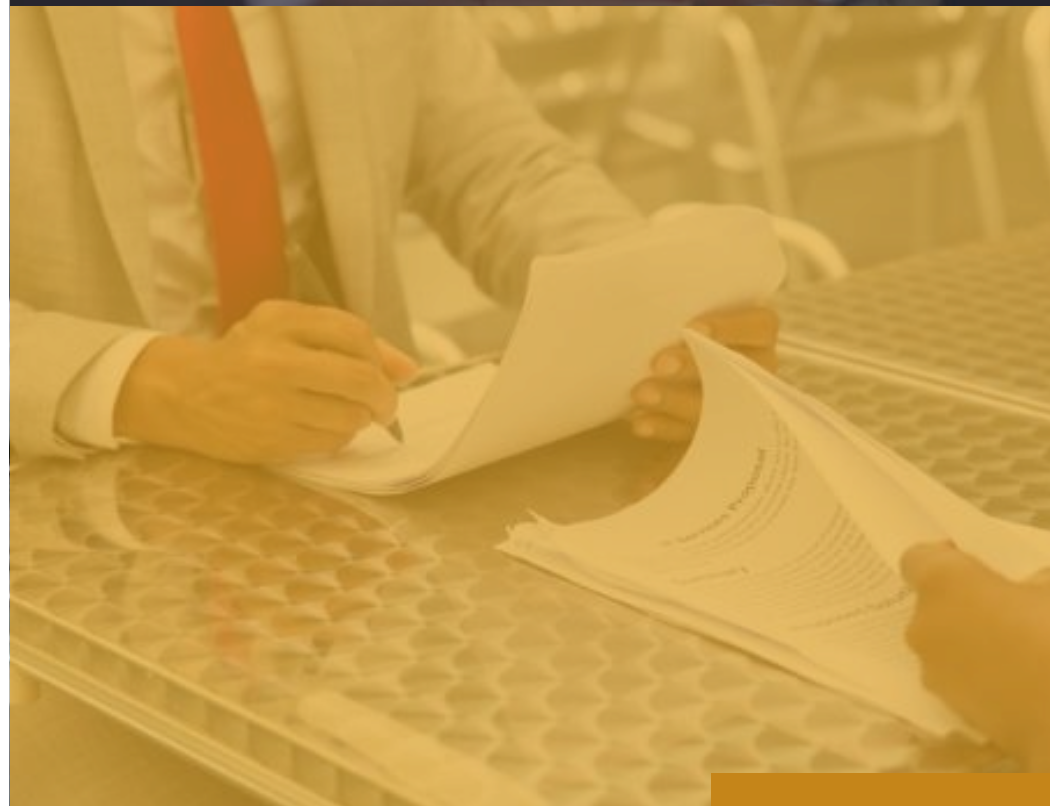
